How Your MBE Score is Calculated - Raw Scores & Scaled Scores There are 175 scored questions, with 25 scored questions from each subject area tested (see chart below). Each scored MBE question is worth one point, for a total of 175 points. This raw score is then converted to a scaled score between 1-200.

If you need a 266 to pass, you should aim to get a 133 on the written portion and a 133 on the MBE. Importantly, you don't "need" a 133 on each portion. You could get a 116 on the MBE and still pass with a higher score of 150 on the written portion. Remember that it's a balancing act.

How Many Correct MBE Questions Do I Need To Pass? - JD ...

Much like the Law School Admission Test (LSAT), there is no true passing or failing grade for the MBE. Instead, the score is combined with those from the other exams comprising the UBE, which then determines whether you pass the bar as a whole. The minimum passing UBE score will vary, depending on the jurisdiction in which it's administered.

How Is the MBE Graded (And What Score Do I Need to Pass)?

Those scores are combined and must be greater than the threshold set by your state for you to pass the bar. Your performance on the MBE is based on how many of those 175 questions you get correct. The formula for converting from the raw score to the scaled score is unique to each MBE and known before any student answers any real question.

How is the MBE Portion of the Bar Exam Scored? - AdaptiBar ...

A 135 is considered to be "passing on the MBE".) If you are in a Uniform Bar Exam (UBE) state, then divide the score you need to pass by two. For example, New York requires a 266 to pass. $266/2 = 133$.
